The Sarbanes-Oxley Act, signed on July 30, 2002 by President Bush, has been called the most important corporate reform legislation since the Securities and Exchange Act of 1934. In an effort to address concerns revealed by Enron and Arthur Andersen matters, the Act addresses auditor independence, corporate responsibility and financial disclosures of publicly traded companies, and conflicts of interests of financial analysts. New protection also exists for "whistle blowers" and criminal penalties have been enacted to address fraud, conspiracy and interference with investigations.
